

SET UP

- 1. Open the shipping carton and carefully remove the unit and all included items from the shipping carton
- 2. Be sure to remove all the packing material especially around the nozzle.
- 3. Set the machine on a flat dry surface. Remove the fluid reservoir cap and carefully fill the fog fluid reservoir with Atmosity Extreme Filtered water based smoke & haze fluid. Once the fluid tank is filled, replace and tighten the reservoir cap.
- 4. Connect the unit to a matching power supply and put the power switch into the "ON" position. Once power is applied, the fan will begin to operate and the machine will begin to heat up. When the machine is heating up, the display will read "HEATING" in the top left corner with the heating percentage.
- 5. The machine takes 6 minutes to heat up. When the machine has reached its operating temperature the display will read "**READY**".
- 6. To emit haze, select your desired operating mode using the touch screen display. See the Control Panel and System Menu sections of this manual.

REMOTE CONTROL

This unit can be operated using the **MagRemote VIDI** remote control, which is a 4-pin, wired remote that can be used to control the volume, intensity, duration, and interval. Please note that the MagRemote VIDI is a universal remote, and some remote functions may not be applicable to all units.

To operate the device using this remote, simply connect the remote's 4-pin male connector to the matching 4-pin female port on the back of the unit, which is labeled "Remote In." The unit will automatically recognize whether or not the remote has been connection. Available functions are listed below:

Manual Button - Unit outputs when button is pressed, and stops when the button is released. LED illuminates when unit is outputting. Settings are set on the device's display screen.

Continuous Button - Unit outputs when button is pressed the first time, and continues to output until the button is pressed again. LED illuminates when unit is outputting. Settings are set on the device's display screen.

Timer On/Off Button - Activates or deactivates the timer function. LED illuminates when function is activated.

Volume Knob - Adjust the speed of the fan.

Intensity Knob - Adjust the amount of fog output.

Duration Knob - Adjust the length of time that the unit will produce fog after reaching the current interval time.

Interval Knob - Adjust the length of time before the unit begins to output fog.



REMOTE DEVICE MANAGEMENT (RDM)

NOTE: In order for RDM to work properly, RDM enabled equipment must be used throughout the entire system, including DMX data splitters and wireless systems.

Remote Device Management (RDM) is a protocol that sits on top of the DMX512 data standard for lighting, allowing the DMX systems of the fixtures to be modified and monitored remotely. This protocol is ideal for instances in which a unit is installed in a location that is not easily accessible.

With RDM, the DMX512 system becomes bi-directional, allowing a compatible RDM enabled controller to send out a signal to devices on the wire, as well as allowing the fixture to respond (known as a GET command). The controller can then use its SET command to modify settings that would typically have to be changed or viewed directly via the unit's display screen, including the DMX Address, DMX Channel Mode, and Temperature Sensors.




CONTROL PANEL


This fixture includes a system menu with an easy to navigate touch screen control panel where all necessary settings and adjustments are made. When first powering on the fixture, the fixture's main menu will be displayed (**see Main Menu Screen below**).

Press the main menu icon you would like to access. Use the **ENTER** button to access sub menus and use the **UP** and **DOWN** buttons to make adjustments. Press the **ENTER** button to confirm your adjustments. You may exit the main menu at any time without making any adjustments by pressing the **BACK/EXIT** button.

TIMER MENU: The timer sub menu includes fog output adjustment, fan adjustment, duration adjustment, and interval adjustment. To access the **TIMER** adjustment menu, press the **SETTINGS** icon located at the bottom of the screen. Use the **UP** and **DOWN** buttons to make your adjustments and press **ENTER** to confirm. When all settings have been made, press the **PLAY/START** button to begin timer fogging.





TROUBLE SHOOTING

If you experience low output, pump noise, or no fog output at all, disconnect and discontinue use immediately. Do not attempt to continue to operate as this may damage the machine. Check the fluid level, the breaker, and be sure the wall outlet is sending power. If all of the above appears to be okay, and the unit fails to operate correctly, the unit will require service. Please contact Magmatic Effects.

CLEANING & MAINTENANCE

When storing your fog machine be sure to store it in a cool area. Cover the machine so that dust does not build up on the unit. When storing the machine for long periods of time, it is highly advised to at least run the machine every 3-4 months. Long periods of inactivity can severly shorten the life of your machine. Only run Atmosity Extreme Filtered Fog Fluid (AEF-4L) through your machine. Never run plain water, vinegar, or any other liquid solution through your machine. Running anything other then water based fog juice will severly damage your machine.
